

SEX OFFENDER REGISTRY LAW SUMMARY OF "SEX OFFENSES" – G.L. 6, § 178C

Registration Requirements and Timelines

A sex offender who was convicted, adjudicated a minor, incarcerated, on probation, on parole or was released from a civil commitment for a sex offense on or after August 1, 1981 is required to register with the SORB.

Sexually Violent Offense	Lifetime registration requirement for adults. Juveniles can ask for relief and/or termination if their only offense
	was committed as a juvenile.
Sex Offense	For a single offense committed as an adult, the offender must register for at least 10 years but not more than 20
Involving a Child	years. Following 10 years of registration and being offense-free, offenders can ask the Board to terminate their
	duty to register.
Wetterling Offense	Lifetime registration for adults with two or more separate sex offense convictions against children committed on
	different occasions.
	Juveniles can ask for relief and/or termination if their only offenses were sex offenses against children committed
	as a juvenile.

Relief of Registration may be granted for these offenses:

Adults: Indecent Assault and Battery

Enticing away a person for prostitution or sexual intercourse

Incestuous marriage or intercourse Possession of Child Pornography

Open and gross lewdness and Lascivious behavior

Juveniles: Any Offense at the time of sentencing by the court or by the SORB at the time of classification.
